Composition comments The ingredients are present in non-hazardous concentrations. A181 is a Cosmetic Product which contains: Aqua, Sodium Laureth Sulfate, Cocamide DEA, Glycerin, Parfum, Disodium EDTA, Benzyl Alcohol, Chloromethylisothiazolinone, Methylisothiazolinone, Triethylene Glycol, Propylene Glycol, Magnesium Chloride, Magnesium Nitrate.

SECTION 4: First aid measures

4.1. Description of first aid measures

Inhalation Unlikely route of exposure as the product does not contain volatile substances. If spray/mist has been inhaled, proceed as follows. Move affected person to fresh air and keep warm and at rest in a position comfortable for breathing.

Ingestion Do not induce vomiting. Give plenty of water to drink. Get medical attention if any discomfort continues.
